Member Zilisch stated he would support this budget. There were no further comments from the public for the Public Budget Hearing on the proposed 2014-2015 Budget.

President Moorhead called for adjournment of this special meeting of the Truth in Taxation and the Public Budget Hearing Meeting.


Truth in Taxation/Public Budget Hearing Meeting was adjourned at 10:25 am.
