1. The meeting was called to order by President Brocker at 9:01 a.m.

Board Roll Call – VP Moorhead present; Secretary Cockrell present; Treasurer Knauss, present; Member Shipley present; President Brocker present. A quorum was present.

2. Call to the Public – read by President Brocker:

Pursuant to A.R.S. 38-431.01 (H), this is an opportunity for the public to comment on any issue within the jurisdiction of the Gila County Community College Provisional District Governing Board. The Board President may determine reasonable time, space, and manner limitations. At the conclusion of an open call to the public, individual members of the Board may respond to criticism made by those who have addressed the Board, may ask staff to review a matter or may ask that a matter be put on a future agenda. Members of the Board will not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

No one approached the Board.

3. Interim President and Board Member Reports

A. Interim President Report – Dr. Janice Lawhorn

- Dr. Lawhorn called the Board's attention to the Student Profile Demographics for both campuses
 that were included in the packet. The most recent information was for Spring 2023 with an
 unduplicated enrollment of 1,361. Dr. Brocker encouraged the Board members to review the
 documents. Approximately 600 of the students are over 65 and 259 students are high school-age
 students.
- Although the Board approved the construction of the new bathrooms on the Gila Pueblo Campus, there seems to be a concern with EAC. Dr. Lawhorn will keep the Board posted.
- Dr. Lawhorn stated she received notice from Arizona Complete Health that the nursing mannikin grant for \$25K was funded. She was also successful in receiving \$35K from the FMI Community Investment Fund to purchase the mannikins.
- Because of the Friends of the Rim Country event reported last month, as requested, Dr. Lawhorn
 indicated she followed up with The Trust to ensure Gila had special event coverage. The Trust
 indicated Gila has this coverage.

• Seven vehicles were sold through the auction on the Gila Pueblo Campus. Dr. Lawhorn contacted The Trust and had them removed from the insurance.

B. President Report – Dr. Jan Brocker

Dr. Brocker asked about the Special Board Meeting to be held on Saturday, November 4, or the
possibility of extending the Regular Board Meeting on Wednesday, November 8. It was
determined the meeting will be held on Saturday, November 4.

C. Vice President Report – Sam Moorhead

- VP Moorhead suggested that with some unrest at the border, we increase our security on campus.
- VP Moorhead suggested the Board consider sponsoring a swim team and offering some drone classes.
- VP Moorhead will be moving to Florence to be closer to his daughter and grandson. He has served 17 years on the Board and this will be his last meeting. He will submit his letter of resignation to Dr. Lawhorn. Dr. Brocker thanked him for his service and dedication.

D. Treasurer/CFO Report – Kurt Knauss

Treasurer Knauss did not have anything to report.

E. Secretary Report-Connie Cockrell

• Secretary Cockrell stated she did not have anything new to report.
