**1. Meeting was called to order by President Brocker at 8:02 a.m.**

**2. Call to the Public**

**No one asked to approach the Board; therefore, President Brocker waived the Call to the Public.**

**2.1 2024-2025 Gila County Provisional Community College District**

**A. Truth in Taxation Hearing**

President Brocker indicated that the Board would hold a Truth in Taxation hearing and hear public comments regarding the proposed 2024-2025 property tax levy increase in accordance with the requirements of A.R.S. Section 15-1461.01(A)(4).

**No one approached the Board.**

**B. Public Hearing on the Proposed 2024-2025 Budget**

Immediately following the Truth in Taxation roll call vote, Dr. Brocker indicated that the Board would now hold a public budget hearing and hear public comments on the proposed 2024-2025 budget as required by A.R.S. Section 15-1461(I).

**No one approached the Board.**

**3. Action Items**

**A. Special Board Meeting on the Truth in Taxation Proposal**

Immediately following the Truth in Taxation Hearing, President Brocker called to order a Special Board meeting as required by statute for the purpose of voting on the Truth in Taxation Proposal for the 2024-2025 Gila County Provisional Community College District Budget. Because the assessed property value increased in Gila County, the tax rate will drop from .9177 to .9048 on the Gila County Provisional Community College District's primary property taxes. Because the reduced rate will generate additional funds, statutory language refers to this as a tax increase, when in fact it is a tax rate reduction of 1.4%. Interim President Lawhorn indicated the proposed increase in primary property taxes to the district will be \$116,604.

**Motion made by Secretary Cockrell, seconded by VP Nye to approve the motion to levy the increased property taxes.**
